Mr. Maier thanked the board for allowing him to be Superintendent for the last 2 years and 9 months. He has enjoyed it immensely. Enrollment at both schools is about the same. ASES attendance has increased in the last three weeks. On Fridays, the ASES students are released at 4:45 p.m. The lunch counts are staying relatively the same for the last 3 months. Mrs. Poletti presented information on providing salad bars for lunch at both schools. She would like to do a trial run for a couple of months. She is looking into some grants for funding, and talking to local farmers about produce. On March 22nd, our solar system will be tied in to PG&E lines. The district is looking at going online, at the Elementary site, with our solar system approximately 2 weeks after the tie-in. Mr. Maier discussed looking to buy a used scissor lift and 30 ft. boom for the district. SIPE will no longer reimburse us for these rental expenses. Ahern has a scissor lift with approximately 256 hours that they would sell to us for \$6300. There will be a ROP board meeting and dinner in Maricopa on the 18th of March. All board members are invited. Mr. Mike Mann and Ms. Tamra Cloud will be attending. Mr. Maier will leave the proposals from Westberg & White with the district office for future reference.
